Subject: Amendment in Environmental Clearance granted under EIA Notification dated 14.09.2006 for establishment of the commercial/hotel project namely "Five Star Hotel" at village- Bharonjia Mullanpur, Punjab to M/s Bhanu Infra Build Pvt. Ltd., (SIA/PB/MIS/242014/2021).

This has reference to your online application submitted on 16.12.2021 for amendment in Environmental Clearance granted under the EIA Notification 14.09.2006 vide letter no SEIAA/2014/1242 dated 06.04.2014 for establishment of the commercial/hotel project namely "Five Star Hotel" in an area of 7.003 acres having built up area of 48027.40 sqm located at village- Bharonjia Mullanpur, Punjab. The proposal of amendment has now been appraised as per procedure prescribed under the provisions of EIA Notification dated 14.09.2006 on the basis of the mandatory documents enclosed with the application viz., Form-4, earlier Environmental Clearance (EC) letter, copy of compliance of condition of Environmental Clearance and additional clarifications furnished.

The SEAC, Punjab in its 210th meeting held on 24.12.2021 after due consideration of the relevant documents submitted, presentation given and additional clarification/ document furnished by the project proponent, has recommended the case to SEIAA for amendment.

The proposal was considered by SEIAA in 197th meeting held on 06.01.2022 wherein SEIAA decided to accept the recommendation of SEAC and allow certain amendments in Environmental Clearance for establishment of the commercial/hotel project namely "Five Star Hotel" in an area of 7.003 acres located at village- Bharonjia Mullanpur, Punjab, subject to the same terms and conditions as imposed in the original Environment Clearance granted vide letter no SEIAA/2014/1242 dated 06.04.2014 with certain additional conditions.

Accordingly, amendment in the Environmental Clearance, is hereby granted subject to same terms and conditions as imposed in the original Environmental Clearance granted vide letter no SEIAA/2014/1242 dated 06.04.2014 to M/s Bhanu Infra Build Pvt. Ltd. with following changes & additional conditions:

Amendments in the earlier granted Environmental Clearance:

Additional Conditions:

- i) The project proponent shall obtain separate permission from Punjab Water Regulation and Development Authority for abstraction of ground water for meeting the total requirement of the project.
- ii) The project proponent shall submit detailed Corporate Environmental Responsibility (CER) plan of Rs. 90 Lacs (0.6 % of total project cost of 150 Crores) to be spent on CER activities including the timelines for its implementation within period of 2 months after assessing the need-based requirement of the locals residing in the vicinity of the project under the Environmental Management Plan (EMP) of the proposed project to SEIAA Punjab for approval. Efforts should be made to prioritise activities which are directly beneficial for the Environment in preference to those which are of a social nature and can be undertaken under the CSR budget of the company. Upon approval, the CER Plan will be included in and form a part of the Environmental Management Plan (EMP) of the project. The CER Plan will be implemented within a time period of 2 years.
- iii) This Environmental Clearance is liable to be revoked without any further notice to the Project Proponent in case of failure to comply with condition number (ii) above.
- iv) The grant of expansion in Environmental Clearance is conditional to the Project Proponent obtaining clearance from the NBWL w.r.t Sukhna Wildlife Sanctuary. The EC does not imply that clearance will be granted to the project by the NBWL and their application in this regard will be considered by the NBWL on merits and decision taken. The investment made in the project, if any, based on environmental clearance being granted, in anticipation of the clearance from the NBWL shall be entirely at the cost and risk of the project proponent and Ministry of Environment and Forests or SEIAA, Punjab, shall not be responsible in this regard in any manner.
