# Starbucks CEO Howard Schultz to step down next year

Howard Schultz, the visionary leader of Starbucks, said on Thursday he would step down as chief executive next year, handing over to his personally selected successor the management of the company he built into the world's largest coffee business, with over 25,000 stores in 75 countries.

Schultz, one of the most visible chief executives in the country, has made Starbucks a vocal part of the national conversation on issues like gun violence, gay rights, race relations, veterans rights and student debt. The succession will take place on April 3, and he will remain at the company as executive chairman, focusing on the company's involvement in social causes and on growing Starbucks Reserve,
