## INDEPENDENT AUDITOR'S REPORT

Report on the Financial Statements

## Opinion

We have audited the accompanying financial statements of Manit Developers Private Limited ("the Company"), which comprise the Balance Sheet as at 31" March 2022, the Statement of Profit and Loss, the Cash Flow statement and the Statement of changes in Equity for the year ended on that date and notes to the financial statements, including a summary of the significant accounting policies and other explanatory information (hereinafter referred to as "the financial statements").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013, as amended ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under section 133 of the Act read with the companies (Indian Accounting Standards) Rules, 2015, as amended, ("Ind As") and other accounting principles generally accepted in India, of the state of affairs of the Company as at 31st March 2022, its loss, its cash flows and the changes in equity for the year ended on that date.

#### Basis for Opinion

#### A. Significant accounting policies

#### 1.Corporate information

#### c)Impairment of financial assets
